

How to incorporate a legacy to support the work of re-homing and caring for dogs at Cliff Top Kennels Re-Homing Centre for anyone who is making or revising a will



**Clause to incorporate into a will for monies to be left to
Cliff Top Kennels Re-homing Centre**

"I give the following charitable legacy absolutely to Cliff Top Kennels Re-homing Centre, registered charity number 1110716 and operating from Cliff Top Kennels, Rocks Lane, Burniston, Scarborough, North Yorkshire, YO13 0HX the sum of £..... for the general purposes of the charity and with the full power to expend the capital as income for the such purposes and I direct that a receipt of the Treasurer or other officer for the time being of the charity shall be good and sufficient discharge to my Executors for the payment to the above named legatee."

**Clause to incorporate into a will for a charitable gift to be left to
Cliff Top Kennels Re-homing Centre.**

"I give the following charitable gifts absolutely to Cliff Top Kennels Re-homing Centre, registered charity number 1110716 and operating from Cliff Top Kennels, Rocks Lane, Burniston, Scarborough, North Yorkshire, YO13 0HX [insert here a description of the items to be bequeathed] with the full power to realise such assets and to apply the proceeds for the general purposes of the charity and I direct that a receipt of the Treasurer or other officer for the time being of the charity shall be good and sufficient discharge to my Executors for the payment to the above named legatee."

Note: If you are leaving items to the charity please make sure that the items are clearly identifiable so that there is no doubt what is being bequeathed.

**Clause to incorporate a residuary bequest to
Cliff Top Kennels Re-homing Centre.**

What this means is that if you are intending to leave your estate to certain individuals and / or causes and if there is anything left when this has been done to leave this to Cliff Top Kennels Re-homing Centre then this is called a residuary bequest and the form of words you might wish to use is as follows:

"I devise and bequest all (or % share of) the residue of my estate absolutely to Cliff Top Kennels Re-homing Centre, registered charity number 1110716 and operating from Cliff Top Kennels, Rocks Lane, Burniston, Scarborough, North Yorkshire, YO13 0HX hereinafter called 'The Charity', such sum to be applied for the general purposes of the charity and I direct that a receipt of the Treasurer or other officer for the time being of the charity shall be good and sufficient discharge to my Executors for the payment to the above named legatee."

Gifts in Memoriam.

It may be that you would prefer that donations are made to Cliff Top Kennels Re-homing Centre instead of floral tributes and this can be set out in your will by including the following of similar wording. Make sure that your executors know your wishes so that action can be taken to make this known at the appropriate time.

"It is my wish that my executor ensure that instead of flowers at my funeral donations are made to Cliff Top Kennels Re-homing Centre, registered charity number 1110716 and operating from Cliff Top Kennels, Rocks Lane, Burniston, Scarborough, North Yorkshire, YO13 0HX
